MEMORANDUM OF RAILCAR LEASE AGREEMENT

THIS MEMORANDUM OF RAILCAR LEASE AGREEMENT dated as of this 28th day of December, 2004, is made by MITSUI RAIL CAPITAL, LLC, a Delaware limited liability company, with an address at 5215 Old Orchard Road, Skokie, IL 60077 (the "Lessee"), and SMBC MARINE FINANCE, INC., a Delaware corporation, with an address at 277 Park Avenue, New York, NY 10172 (the "Lessor" and, together with the Lessee, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee have previously entered into that certain Lease Agreement dated as of December 28, 2004 (the "Railcar Lease") and Schedule No. 001 thereto dated as of December 28, 2004 ("Schedule 1") (the Railcar Lease and Schedule 1 are hereinafter collectively referred to as the "Lease") covering the railcars listed on Exhibit A hereto (the "Railcars");

WHEREAS, the Parties wish to acknowledge for the public record the existence of the aforesaid Lease, and the respective interests therein of the Parties and accordingly the Parties have caused this Memorandum to be executed by their respective duly authorized officers, as of the date first above written.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the Parties hereto, by this instrument the Lessor hereby leases and confirms the lease of the Railcars to the Lessee in accordance with the terms and conditions of the Lease, and the Lessee hereby leases and confirms the lease of the Railcars from the Lessor and accepts the terms and conditions of the Lease, which are incorporated by reference as if fully set forth herein.


