**THIS AMENDMENT TO MEMORANDUM OF LEASE** (the "Memorandum of Lease") as of this the 30<sup>th</sup> day of November, 2004, by and between ~~First Union Rail Corporation~~ **SURFACE TRANSPORTATION BOARD** ("Lessor"), a North Carolina corporation, and Galamba Metals Group, LLC ("Lessee"), Missouri limited liability company.




