FULL RELEASE OF SECURITY INTEREST
SURFACE TRANSPORTATION BOARD

The undersigned, LASALLE BANK, NATIONAL ASSOCIATION ("Secured Party"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge the security interest held by the Secured Party on that certain railroad equipment identified as eighty-one (81) railcars consisting of fifty-three (53) covered hopper cars bearing AMCX reporting marks and road numbers 6200 through 6253 (excluding 6236), eighteen (18) pressure tank cars bearing AMCX reporting marks and road numbers 031067 through 031085 (excluding 031073) and ten (10) general purpose tank cars bearing AMCX reporting marks and road numbers 023006 through 023015.


