WITNESSETH:

1. The Owner Trustee and BNSF Railway Company ("*Lessee*") have entered into an Equipment Lease Agreement (BNSF 2005-E), dated as of August 1, 2005, and Lease Supplement No. 1 thereto, dated August 3, 2005, covering certain railroad equipment bearing reporting marks as listed on Exhibit A attached hereto.




