

**WITNESSETH**

This Memorandum of Lease is entered into as of the 25<sup>th</sup> day of July, 2005, by and between NARCAT LLC, an Delaware corporation, having its principal place of business at Suite R, 480 W. Dussel Drive, Maumee, OH 43537 (hereinafter "Lessor") and Lansing Grain Company, LLC, a Michigan limited liability company, having its principal place of business at 8005 W. 110th St., Suite 200, Overland Park, KS 66210 (hereinafter "Lessee").

1. 

