**PARTIAL RELEASE OF LIEN

This Partial Release of Lien of Railroad Equipment Lease (the "Release") releases the lien created by that certain Railroad Equipment Lease dated as of January 24, 2000 (the "Lease"), bearing Recordation No. 22945, between Joseph Leasing Ltd. as Lessor ("Lessor") and Envirocare of Utah, In., (as assigned by Zhagrus Environmental, Inc.), as Lessee ("Lessee"), with respect to the twenty-four (24) railcars listed on Exhibit A attached hereto (hereinafter, the "Equipment").


1. The Lease was terminated for the twenty-four (24) railcars.


