

THIS TERMINATION OF MEMORANDUM OF LOAN AND SECURITY AGREEMENT is made as of May 5, 2004 by Banc One Leasing Corporation ("Banc One"), as Lender and **SPERRY RAIL, INC. ("Sperry")**, as Borrower.

WITNESSETH:
