SURFACE TRANSPORTATION BOARD

THIS MEMORANDUM OF LEASE, LEASE SUPPLEMENT NO. 1 AND LEASE SUPPLEMENT NO. 2 dated as of September 30, 2005, is between WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION, as Owner Trustee (the "Lessor"), and THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation (the "Lessee").






