MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE SCHEDULES
(Surface Transportation Board)

THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE SCHEDULES (this "Memorandum") dated as of November ~~30~~, 2005 is between The CIT Group/Equipment Financing, Inc. (the "Seller") and Midwest Railcar Corporation (the "Buyer").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. 1. The Seller has leased to International Chemical Company, as lessee ("ICC"), fifteen (15) covered hopper railcars equipped with gravity gates and trough hatches identified on Schedule A-1 attached hereto (the "ICC Railcars") under that certain Schedule No. 01 to Master Railcar Lease made as of March 23, 2005 by and between the Lessee and ICC, incorporating the terms of that certain Master Railcar Lease made as of March 23, 2005 (Schedule No. 01 and the Master Lease Agreement, as it relates only to the ICC Railcars, the "ICC Lease").

2. The Seller has leased to Meow Mix Decatur Productions 1 LLC, as lessee ("Meow Mix"), four (4) covered hopper railcars equipped with gravity gates and trough hatches identified on Schedule A-2 attached hereto (the "Meow Mix Railcars") under that certain Schedule No. 01 to Master Railcar Lease made as of December 6, 2002 by and between the Lessee and Meow Mix, as extended pursuant to an Extension to Lease Schedule No. 01, dated as of February 11, 2005 for the period January 1, 2005 through December 31, 2006, incorporating the terms of that certain Master Railcar Lease made as of December 6, 2002 (Schedule No. 01, as so extended, and the Master Lease Agreement, as it relates only to the Meow Mix Railcars, the "Meow Mix Lease").

3. The Seller has leased to Michigan Agricultural Commodities, Inc., as lessee ("Michigan Ag"), twenty-five (25) covered hopper railcars equipped with gravity gates and trough hatches identified on Schedule A-3 attached hereto (the "Michigan Ag Railcars") under that certain Schedule No. 02 made as of January 2, 2005, by and between Michigan Ag and the Seller, incorporating the terms of that certain Master Railcar Lease, made as of December 27, 2004 (Schedule No. 02 and the Master Lease Agreement, as it relates only to the Michigan Ag Railcars, the "Michigan Ag Lease").

^{seventy-eight (78)} The Seller has leased to Mississippi Lime Company, as lessee ("Mississippi Lime"), ~~seventy-eight (78)~~ covered hopper railcars equipped with gravity gates and trough hatches identified on Schedule A-4 attached hereto (the "Mississippi Lime Railcars") under that certain Schedule No. 01 made as of August 31, 1999, by and between Mississippi Lime and the Seller, as extended pursuant to an Extension to Lease Schedule No. 01, entered into as of September 20, 2005, incorporating the terms of that certain Master Railcar Lease, made as of August 13, 1999 (Schedule No. 01 and the Master Lease Agreement, as it relates only to the Mississippi Lime Railcars, the "Mississippi Lime Lease").

5. The Seller has leased to Potash Import and Chemical Corporation, as lessee ("Potash"), eleven (11) covered hopper railcars equipped with gravity gates and trough hatches identified on Schedule A-5 attached hereto (the "Potash Railcars") under that certain Schedule No. 01 made as of October 21, 2002, by and between Potash and the Seller, as extended pursuant to an Extension to Lease Schedule No. 01, entered into as of November 1, 2004 for the period November 1, 2005 through October 31, 2007, incorporating the terms of that certain Master Railcar Lease, made as of October 31, 2002 and as amended by an Amendment No. 1 to Extension to Lease Schedule, dated November 18, 2005 (Schedule No. 01, as so extended and amended and the Master Lease Agreement, as it relates only to the Potash Railcars, the "Potash Lease").

6. The Seller has leased to Cargill Incorporated, as original lessee (the "Original Lessee"), under that certain Schedule No. 17 made as of April 11, 2002, by and between the Original Lessee and the Seller, as extended pursuant to an Extension to Lease Schedule No. 17, dated April 1, 2003 with respect to only sixty-three (63) covered hopper railcars equipped with gravity gates and trough hatches identified on Schedule A-6 attached hereto (the "Mosaic Railcars") and which was assigned by the Original Lessee to and assumed by The Mosaic Company ("Mosaic") pursuant to a Lease Transfer and Assumption Agreement entered into by the Seller, the Original Lessee and Mosaic dated as of October 21, 2004, as extended by an Extension to Lease Schedule No. 17 dated July 17, 2005 incorporating the terms of that certain Master Railcar Lease, made as of October 8, 1997, by and between the Original Lessee and the Seller (Schedule No. 17, as so extended, incorporating the Master Lease Agreement, as it relates only to the Mosaic Railcars, the "Mosaic Lease").

The ICC Lease, the Meow Mix Lease, the Michigan Ag Lease, the Mississippi Lime Lease, the Potash Lease and the Mosaic Lease are collectively referred to as the "Leases."

B. 1. Evidence of the ICC Lease in its original form was recorded with the Surface Transportation Board (the "STB") by filing a Memorandum of Railcar Lease Agreement by and between the original lessor and the original lessee dated March 23, 2005, with the STB on August 4, 2005, under Recordation No. 25756.

2. Evidence of the Meow Mix Lease in its original form was recorded with the STB by filing a Memorandum of Railcar Lease Agreement by and between the original lessor and the original lessee dated December 6, 2002, with the STB on March 12, 2003, under Recordation No. 24357.

3. Evidence of the Michigan Ag Lease in its original form was recorded with the STB by filing a Memorandum of Railcar Lease Agreement by and between the original lessor and the original lessee dated December 24, 2004, with the STB on August 4, 2005, under Recordation No. 25755-A.

4. Evidence of the Mississippi Lime Lease in its original form was recorded with the STB by filing a Memorandum of Railcar Lease Agreement by and between the original lessor and the original lessee dated August 13, 1999, with the STB on January 20, 2000, under Recordation No. 22726.

5. Evidence of the Potash Lease in its original form was recorded with the STB by filing a Memorandum of Railcar Lease Agreement by and between the original lessor and the original lessee dated October 31, 2002, with the STB on March 14, 2003, under Recordation No. 24359.

6. Evidence of the Mosaic Lease in its original form was recorded with the STB by filing a Memorandum of Railcar Lease Agreement by and between the original lessor and the original lessee dated October 21, 2004, with the STB on November 3, 2004, under Recordation No. 25274.

C. The Seller, as assignor, and the Buyer, as assignee, are parties to that certain Assignment and Assumption Agreement, dated as of even date herewith, pursuant to which the Seller has assigned to the Buyer all of the Seller's rights, title and interest in, and all obligations under the Leases, except to the extent constituting Excluded Rights and Obligations (as defined in the Assignment and Assumption Agreement). The terms of the assignment are more particularly set forth in the above-referenced Assignment and Assumption Agreement.

D. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date

first above written. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.






