FULL RELEASE OF ASSIGNMENT OF LEASE AND RENTS

SURFACE TRANSPORTATION BOARD

THIS FULL RELEASE OF ASSIGNMENT OF LEASE AND RENTS (this "Full Release") is given as of this 23rd day of December, 2005, by THRIVENT FINANCIAL FOR LUTHERANS (formerly known as Aid Association for Lutherans) (the "Lender"), witnesseth:

WHEREAS, the Lender, as lender, and The First National Bank of Maryland (predecessor-in-interest to Allfirst Bank, predecessor-by-merger to Manufacturers and Traders Trust Company) (the "Debtor"), as debtor, entered into that certain Assignment of Lease and Rents dated as of August 24, 1995 deposited with the Surface Transportation Board (the "STB") on August 24, 1995 under recordation number 19514-C relating to the Railroad Equipment Lease (including all Riders and Schedules thereto) dated May 26, 1995 between the Debtor, as successor lessor, and Union Pacific Railroad Company (successor-in-interest to Chicago and North Western Railway Company), as lessee (the "Lessee"), pursuant to which the Debtor has leased to the Lessee certain covered hopper railcars referenced therein (the "Lease"). The Debtor assigned its obligations under such Assignment of Lease and Rents (as so assigned, the "Assignment of Lease and Rents") to M&T Credit Corporation (predecessor-by-merger to M&T Credit Services, LLC) pursuant to the Assignment Agreement and the Acceptance and Assumption Agreement, each dated as of July 7, 2003 and each by and between Manufacturers and Traders Trust Company, as assignor, and M&T Credit Corporation, as assignee, which assignment was memorialized by filing a Memorandum of Assignment dated as of July 7, 2003 with the STB on September 16, 2003 under recordation number 19514-E.

WHEREAS, the Lender desires to fully release the lien against the Lease created by or arising out of the Assignment of Lease and Rents.

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender submits the following:

1. The Lender hereby fully releases the lien against the Lease created by or arising out of the Assignment of Lease and Rents.
2. This Full Release shall be deposited with the STB so as to record the Lender's full release of the lien against the Lease constituted by the Assignment of Lease and Rents.


