

TERMINATION OF LEASE

This Termination of Lease, effective January 3, 2006, terminates Rider No. 1 dated as of October 1, 1990 (to the Loading Agreement dated as of October 1, 1990) between Greenbrier Leasing Company LLC, formerly known as Greenbrier Leasing Corporation, Lessor, and Kansas City Southern Railway Company and Louisiana & Arkansas Railway Company, (jointly referred to as Lessee), covering approximately two hundred (200) 89-foot, TOFC flatcars bearing marks and numbers as follows: KCS 8600 through KCS 8799, inclusive.

A Memorandum of Lease Agreement dated as of October 1, 1990 between the Lessor and the Lessee evidencing such Rider No. 1 (and such Loading Agreement) was recorded with the Interstate Commerce Commission on March 4, 1991 at 3:05 p.m. and assigned primary Recordation Number 17244.

This Termination of Lease shall not impair or terminate the rights and obligations of the parties under such Rider No. 1 (and such Loading Agreement) which expressly survive its termination.
