This Termination of Lease, effective January 3, 2006, terminates Rider No. 1 dated as of April 24, 1991 (to the Lease Agreement dated as of April 24, 1991) between Greenbrier Leasing Company LLC, formerly known as Greenbrier Leasing Corporation, Lessor, and Wisconsin Central, Ltd., Lessee, covering eighty-four (84) 89'4" flush two 45" trailers or containers with a gross individual weight of 65,000 pounds bearing marks and numbers as follows: WC 36200 through WC 36283, inclusive.

A Memorandum of Lease Agreement dated as of April 24, 1991 between the Lessor and the Lessee evidencing such Rider No. 1 (and such Lease Agreement) was recorded with the Interstate Commerce Commission on December 9, 1991 at 10:15 a.m. and assigned primary Recordation Number 17613.
