This Release of Lien of Railroad Equipment Lease (the "Release") releases the lien created by that certain Railroad Equipment Lease dated as of November 2, 1999 (the "Lease"), bearing Recordation No. 22587 filed on December 8, 1999 and a duplicate filing bearing Recordation No. 22749 filed February 7, 2000, between The David J. Joseph Company (f/k/a DJJ Transportation Services, Inc.), as Lessor ("Lessor") and Lantic Sugar Limited, as Lessee ("Lessee"), (such Lease hereinafter referred to as the "Lease") with respect to ten (10) railcars bearing reporting marks within the series DJTX 70500 through DJTX 70509, inclusive (hereinafter, the "Equipment").

WHEREAS, Lessor and Lessee executed the Lease relating to the Equipment. Such Lease has expired; and

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lessor submits the following:

1. Lessor has sold the Equipment as of February 28, 2006.
2. All interest of the Lessor, its successors and assigns, in the Equipment arising pursuant to the Lease has been terminated.
3. The Lessor hereby releases any lien(s) created by or arising out of the Lease.
4. This Release shall be recorded with the Surface Transportation Board so as to record the release of the lien(s) against the Equipment constituted by the Lease.


