THIS MEMORANDUM OF RAILCAR LEASE dated as of this 13 day of Sept., 2005, is made by THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, with an address at 1211 Avenue of the Americas, 20th Floor, New York, New York 10036 (the "Lessor"), and EQ NORTHEAST, INC., a Massachusetts corporation, with an address at 185 Industrial Road, P.O. Box 617, Wrentham, MA 02093 (the "Lessee" and, together with the Lessor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee entered into that certain Master Railcar Lease (the "Lease") dated as of September 3, 2003 covering certain equipment described therein and with respect to which a Memorandum of Railcar Lease was filed with the Surface Transportation Board ("STB") on January 13, 2004 and given Recordation Number 22803-C.
