**RESTATED MEMORANDUM OF LEASE AGREEMENT**

SURFACE TRANSPORTATION BOARD

Restated Memorandum of Lease Agreement effective as of March 31, 2006 by Trinity Industries Leasing Company, a Delaware corporation (the "Lessor").

**W I T N E S S E T H:**

The Lessor and Cemex USA Cement, Inc., a Delaware corporation (the "Lessee") have entered into that certain Railroad Car Lease Agreement, dated as of February 8, 2000, whereby the Lessor has agreed to lease to the Lessee and the Lessee has agreed to lease from the Lessor certain railroad cars as listed on Rider Ten (10) to Railroad Car Lease Agreement, dated as of September 1, 2005 (the "Lease Agreement").

1. Memorandum of said Lease Agreement was recorded on March 31, 2006 with the Surface Transportation Board pursuant to the provisions of 49 U.S.C. Section 11301(a) as Recordation Number 26277-A (the "Memorandum of Lease").


