TO MASTER LEASE AGREEMENT 1488



THIS MEMORANDUM OF ASSIGNMENT OF BASE TERM RIDER NO. 006 TO MASTER LEASE AGREEMENT 1488 (this "Memorandum") is made as of June 2, 2006 by and between ICX CORPORATION, d/b/a RBS ASSET FINANCE an Ohio corporation (the "Assignor") and LASALLE NATIONAL LEASING CORPORATION, a Delaware corporation (the "Assignee").

- A. The Assignor and the Assignee are parties to that certain Specification of Assigned Equipment Schedule (the "Specification") dated as of June 2, 2006 pursuant to which the Assignor assigned to the Assignee and the Assignee purchased from the Assignor all of the Assignor's right, title and interest in and to Base Term Rider No. 006, dated as of May 12, 2006 (the "Lease") and issued pursuant to the Master Lease Agreement dated June 30, 2005 between Assignor, as lessor, and Union Pacific Railroad Company, as lessee ("Lessee").
- B. Pursuant to the Lease, Assignor has leased to Lessee ninety-seven (97) mechanical Refrigerator Box Cars bearing identification numbers (collectively, the "Railcars") on the attached Exhibit A.




