**MEMORANDUM OF LEASE ASSIGNMENT
(BNSF 2006-L)** SURFACE TRANSPORTATION BOARD

Memorandum of Lease Assignment, made and entered into as of August 9, 2006, by and between U.S. Bank Trust National Association, a national banking association, not in its individual capacity, but solely as Owner Trustee ("*Owner Trustee*") of the BNSF 2006-L Statutory Trust, and Wells Fargo Bank Northwest, National Association, a national banking association, as Indenture Trustee ("*Indenture Trustee*").






