

MEMORANDUM OF ASSIGNMENT AND AGREEMENT

This Memorandum of Assignment and Agreement is dated as of August 23, 2006 by and between LASALLE NATIONAL LEASING CORPORATION ("LASALLE"), One West Pennsylvania Avenue, Towson, MD 21204, the assignor, and JOHN HANCOCK LEASING CORPORATION, 197 Clarendon Street, C-2, Boston, MA 02116 ("JOHN HANCOCK"), the assignee.

WITNESSETH:



LASALLE, as lessor, entered into a Locomotive Lease Agreement (the "Lease") dated as of April 25, 2006 by and among LASALLE, as lessor, National Railway Equipment Company, and BNSF Railway Company, as lessee, for certain locomotives identified in the Attachment (the "Locomotives") to lessee. A Memorandum of Lease dated as of May 11, 2006 was recorded on May 12, 2006 at the Surface Transportation Board (the "Board") under Recordation No. 26320-A.

2. LASALLE and JOHN HANCOCK have entered a Master Assignment Agreement dated as of July 24, 2006, which is evidenced by this Memorandum of Assignment and Agreement with respect to the Locomotives.


