
MEMORANDUM OF SCHEDULE #14 TO FULL SERVICE MASTER LEASE AGREEMENT

THIS MEMORANDUM OF SCHEDULE #14 TO FULL SERVICE MASTER LEASE AGREEMENT is effective as of March 1, 2006, by and between MIDWEST RAILCAR CORPORATION, an Illinois Corporation ("Lessor"), and BADGER MINING CORPORATION, a Wisconsin Corporation ("Lessee"), with reference to the following:


