MEMORANDUM OF ASSIGNMENT OF LEASE

SURFACE TRANSPORTATION BOARD

THIS MEMORANDUM OF ASSIGNMENT OF LEASE dated as of this 28 day of September, 2006, is made by AIG COMMERCIAL EQUIPMENT FINANCE, INC. a Delaware corporation, with an address at 5700 Granite Parkway, Suite 850, Plano, TX 75022 (the "Transferor"), and THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, with an address at 505 Fifth Avenue, New York, NY 10017 (the "Transferee" and, together with the Transferor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, Transferor and Transferee entered into that certain Purchase Agreement (the "Purchase Agreement") dated as of September 28, 2006 relating to the sale by Transferor to Transferee of one hundred forty (140) 2005-built BethGon II gondola railcars identified on Schedule 1 (the "Equipment") and the assignment by Transferor and assumption by Transferee of Transferor's right, title and interest in, and obligations under the Net Lease Agreement, dated as of June 22, 2005, but only as it relates to the Units and originally entered into between Mitsui Rail Capital, LLC, a Delaware limited liability company ("Mitsui"), as lessor, and Tuscon Electric Power Company, as lessee (the "Lease Agreement") and Schedule No. 1 thereto, dated June 22, 2005 and entered into between Mitsui, as lessor, and Tuscon Electric Power Company, as lessee ("Schedule 1"; Schedule 1 and the Lease Agreement as it relates to Schedule 1, collectively, the "Lease");

WHEREAS, the Equipment is subject to the Lease;

WHEREAS, a Memorandum of Lease Agreement with respect to the Lease was filed with the Surface Transportation Board (the "STB") on August 2, 2005, and assigned recordation number 25747; and

WHEREAS, Mitsui sold the Equipment to Transferor and assigned the Lease to Transferor pursuant to a Purchase Agreement, dated as of September 6, 2005, which sale and Assignment was reflected in a Memorandum of Assignment of Lease, dated as of the 6th day of September, 2005, filed with the STB on September 6, 2005 at 3:38 PM and assigned recordation number 25747-A; and

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid agreement by Transferor to the further transfer of all Transferor's right, title and interest in, to and obligations under, the Lease to Transferee, and accordingly the Parties have caused this Memorandum to be executed by their respective duly authorized officers, as of the date first above written.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the parties hereto, by this instrument the Transferor hereby confirms the sale of the Equipment to Transferee and the assignment to Transferee of Transferor's right, title and interest in, and obligations under, the Lease in accordance with the terms and conditions of the Purchase Agreement, and the Transferee confirms and accepts such conditions, which are incorporated by reference as if fully set forth herein.
