AMENDMENT

SURFACE TRANSPORTATION BOARD

THIS AMENDMENT to the Master Lease Agreement, dated as of August 15, 1995, Equipment Lease Schedule Nos. 1 and 2, dated as of September 6, 1995 and September 15, 1995, respectively, and the Memorandum of Equipment Lease, dated as of September 15, 1995, and the underlying schedules and attachments thereto (collectively, the "Lease") by and between MELLON LEASING CORPORATION (formerly Mellon Financial Services Corporation #3) ("Lessor") and ILLINOIS CENTRAL RAILROAD COMPANY ("Lessee"), is made as of the 28 day of February, 2001 by and between Lessor and Lessee.

WHEREAS, Lessor and Lessee entered into the Lease for various items of railroad rolling stock as indicated therein and in the schedules and attachments thereto (the "Equipment");

WHEREAS, two items of Equipment (100-ton gondola cars bearing South Buffalo identification numbers 6023 and 6065) were mistakenly both assigned Lessee identification number IC 295925;

WHEREAS, car SB 6023 should have been identified as IC 295935;

WHEREAS, information regarding the Lease and the Equipment was recorded pursuant to the provisions of Section 11303 of the Interstate Commerce Act on 8-9-96 and assigned recordation number 20219; and

WHEREAS, the parties wish to amend the Lease and its underlying documents as indicated herein.

NOW, THEREFORE, in consideration of the mutual promises contained within the Lease and the promises contained herein and for other good and sufficient consideration, the parties, intending to be legally bound, agree as follows:

1. The Lease and all related certificates, memoranda, attachments and schedules identifying the Equipment subject to the Lease shall be amended to identify car SB 6023 as IC 295935 rather than as IC 295925.

2. If any provision of this Amendment conflicts in whole or in part, with the terms and conditions of the Lease or any document related to the transaction therein, then the provisions of this Amendment shall control. All other terms and conditions of the Lease and related documents remain unchanged.
