KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, WELLS FARGO BANK (TEXAS), NATIONAL ASSOCIATION ("Lender") was the owner and holder of certain indebtedness (the "Indebtedness") of ROBERT R. 
