

NOTICE OF CORRECTION

LaSalle Bank National Association ("LBNA") on this 20th day of October 2006 hereby notifies the Surface Transportation Board of a correction in the Partial Termination and Release of Security Interests and Liens recorded under Recordation Nos. 17636-GGG, 19632-CCC, and 24626-EE (the "Partial Release").

The reference to locomotive number PRSX 1009 in the Partial Release was based on erroneous information provided by National Railway Equipment Company ("NREC"). Locomotive number FWR 5007 was renumbered BNSF 2038 instead of locomotive number PRSX 1009.

LBNA corrects the Partial Termination and Release of Security Interests and Liens recorded under Recordation Nos. 17636-GGG, 19632-CCC, and 24626-EE by substituting locomotive number FWR 5007 for locomotive number PRSX 1009. Locomotive number PRSX 1009 remains subject to the liens that NREC has granted LBNA.
