

LOCOMOTIVE OPERATING LEASE AGREEMENT PARTIAL TERMINATION

This Locomotive Operating Lease Agreement Partial Termination dated as of May 8, 2000 (the "Partial Termination") terminates the Locomotive Operating Lease Agreement, dated as of December 22, 1989 (the "Lease"), between General Motors Corporation (Electro-Motive Division) ("EMD"), a Delaware corporation, and ^{THE} Burlington Northern and Santa Fe Railway Company ("BNSF"), successor by merger to The Atchison, Topeka and Santa Fe Railway Company, a Delaware corporation, with respect to two SD-60 locomotives numbered EMDX 8301 and 8302 (the "Locomotives").

WHEREAS, EMD and BNSF executed a Locomotive Operating Lease Agreement, dated as of December 22, 1989;

WHEREAS, the Lease was duly filed for recordation with the Interstate Commerce Commission pursuant to 49 U.S.C. § 11303 on January 11, 1990 at 1:55 p.m., and was filed under Recordation No. 16720; and

WHEREAS, EMD and BNSF desire to terminate and cancel the Lease in part and to record this partial termination and cancellation with respect to the Locomotives;

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt of which is acknowledged, EMD and BNSF agree as follows:

1. EMD and BNSF hereby in part terminate and cancel the Lease with respect to the Locomotives.
2. EMD and BNSF agree to record this Partial Termination with the Surface Transportation Board so as to release the lien with respect to the Locomotives.
3. This Partial Termination may be executed by the parties in any number of counterparts, each executed counterpart constituting an original but altogether one and the same instrument.


