

TERMINATION OF EQUIPMENT TRUST AGREEMENT

THIS TERMINATION OF EQUIPMENT TRUST AGREEMENT is made and entered into as of January 2, 2007 by and between THE BANK OF NEW YORK TRUST COMPANY, N.A. (successor-in-interest to Ameritrust Texas, N.A.), not in its individual capacity, but solely as Owner Trustee ("*Owner Trustee*") and BNY MIDWEST TRUST CO. (successor-in-interest to Mercantile-Safe Deposit and Trust Company), as Security Trustee (the "*Security Trustee*").

1. The Owner Trustee has heretofore entered into that certain Equipment Lease Agreement (No. 36-B) with TTX Company dated as of June 30, 1992 (as amended, modified or supplemented to date, the "*Lease*"), a copy of which was duly recorded with the Interstate Commerce Commission on June 30, 1992 at 10:25 A.M. under recordation number 17833. The Lease was assigned to the Security Trustee by virtue of an Equipment Trust Agreement (No. 36-B) dated as of June 30, 1992 (as amended, modified or supplemented to date, the "*Equipment Trust Agreement*"), a copy of which was duly recorded with the Interstate Commerce Commission on June 30, 1992 at 10:25 A.M. under recordation number 17833-A.

2. The Equipment Trust Agreement is terminated effective as of the date hereof with respect to the railroad equipment set forth on Exhibit A hereto.

3. This Termination of Equipment Trust Agreement shall neither impair nor terminate the rights and obligations of the parties under the Equipment Trust Agreement which expressly survive this termination.


