

**NOTICE OF PARTIAL TERMINATION**

**SURFACE TRANSPORTATION BOARD**

This Notice of Partial Termination is effective as of October 1, 2006.

**RECITALS:**

A. Pursuant to Schedule No. 2 dated as of May 1, 2000 to the Lease Agreement dated February 20, 2000 between Greenbrier Leasing Company LLC, formerly known as Greenbrier Leasing Corporation, ("Lessor") and Linea Coahuila Durango, S.A. de C.V. ("Lessee"), Lessor leased eighty (80) 53-foot, 100-ton, 3,638 cu. ft. quad hopper cars with 45-degree slope sheets and manual discharge gates, marked and numbered GBRX 94000 through GBRX 94079, inclusive (the "Cars") to Lessee.

Lessor and Lessee executed a Memorandum of Lease for Schedule No. 2 dated May 1, 2000, (the "Memorandum") reflecting the lease of the Cars from Lessor by Lessee.


