

SURFACE TRANSPORTATION BOARD

This MEMORANDUM OF RAILROAD EQUIPMENT LEASE ("Memorandum of Lease") entered into this 7<sup>th</sup> day of November, 2006, is intended to evidence the lease dated as of November 7, 2006 (the "Lease"), between THE DAVID J. 




