RELEASE OF LIEN

SURFACE TRANSPORTATION BOARD

This Release of Lien (the "Release") releases the lien created by the filing of that certain Master Lease Agreement No. 136 and Lease Schedule No. 001 dated November 21, 1996 (the "Lease"), bearing Surface Transportation Board ("STB") Recordation No. 20395 and 20395-A, filed on December 11, 1996, between The Vaughn Group, Ltd. (hereinafter referred to as "Lessor") and Atlas Iron Processors, Inc. and M.A.D., Inc. (hereinafter referred to as the "Co-Lessees"), relating to forty (40) railcars as set forth in Schedule I attached hereto (hereinafter, the "Equipment").

WHEREAS, the Lease was assigned to First Merit Corporation (f/k/a First National Bank of Ohio), as Lessor, dated as of December 9, 1996, and filed under Recordation No. 20395-B. Such Lease has expired;


WHEREAS, The David J. Joseph Company ("DJJ") has purchased the Equipment from First Merit Corporation, and by such act, all interest of First Merit Corporation, its successors and assigns, in the Equipment arising pursuant to the Lease has been terminated;

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, First Merit Corporation submits the following:

1. DJJ has purchased the Equipment from First Merit Corporation on January 11, 2001.
2. All interest of First Merit Corporation, its successors and assigns, in the Equipment arising pursuant to the Lease have been terminated.
3. This Release shall be recorded with the Surface Transportation Board so as to record the release of the lien against the Equipment constituted by the Lease and subsequent filings. This Release shall bear Recordation Number 20395-C.

IN WITNESS WHEREOF, DJJ has caused this Release to be duly executed by its authorized officer as of the 16th day of January, 2007.


