

The undersigned have entered into that certain Trust Indenture and Security Agreement (BNSF 2007-B), dated as of February 1, 2007 (the "*Trust Indenture*"), by which the Owner Trustee has granted a security interest to the Indenture Trustee in order to secure the Owner Trustee's performance of certain obligations as described in the Trust Indenture.






