

## MEMORANDUM OF RAILCAR LEASE

## Supplement No. 19

This Memorandum of Railcar Lease, made and entered into as of December 18, 2006, is by and between GATX Financial Corporation ("Lessor"), and ConocoPhillips Company ("Lessee").

## WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and Lessee has agreed to lease from Lessor the rail cars described on the Exhibit A attached hereto, bearing marks and numbers as described on the attached Exhibit A.
2. The railcars are fully described in a certain Railcar Lease Agreement, dated June 21, 2006, and a Lease Supplement No. 19, dated as of December 18, 2006 (together with all of their riders, schedules and other attachments thereto, collectively the "Lease"), each between Lessor and Lessee.
3. The Lease of the rail cars shall be effective as of the date first set forth hereinabove and shall be subject to the lease term as described in the Lease.
4. This Memorandum of Railcar Lease may be executed in any number of counterparts, each of which shall be an original, all of which when taken together shall constitute one agreement binding on all parties, notwithstanding that all parties are not signatories to the same counterpart.


