TERMINATION AND RELEASE

THIS TERMINATION AND RELEASE (this "Termination"), is made as of this 16 day of April, 2007, by and between Mitsui & Co. (U.S.A.), Inc., a New York corporation ("Mitsui USA") and Mitsui Rail Capital, LLC, a Delaware limited liability company (formerly known as MRC Rail Services, LLC) ("MRC").

WHEREAS, Mitsui USA and MRC are parties to that certain Purchase and Lease Agreement, dated as of April 10, 2001 (the "Original Lease"), between Transferor and Transferee, as amended by Amendment #1 of Purchase and Lease Agreement dated as of April 10, 2003 ("Amendment #1") and Amendment #2 of Purchase and Lease Agreement dated as of August 5, 2003 ("Amendment #2"; the Original Lease, as amended by Amendment #1 and Amendment #2, is hereinafter referred to as the "Lease Agreement") and as supplemented by Schedule No. 1 dated as of April 10, 2001 ("Schedule 1") and Schedule No. 2 dated as of April 10, 2001 ("Schedule 2"; and together with Schedule 1, the "Schedules"), with respect to certain equipment described on Schedule A attached hereto (the "Equipment"); and

WHEREAS, Mitsui USA and MRC are parties to a Memorandum of Lease Agreement dated as of April 10, 2001 (the "Memorandum") with respect to the Equipment and certain other equipment; and

WHEREAS, multiple copies of the Memorandum were duly filed for recordation with the Surface Transportation Board (the "STB") pursuant to 49 U.S.C. Section 11301, on August 3, 2001 and assigned Recordation Numbers 22738-B, 22739-B, 23044-B and 23580-A; and

WHEREAS, Mitsui USA and MRC are parties to a Partial Termination and Release dated as of October 13, 2004 (the "Partial Termination") with respect to certain equipment described therein; and

WHEREAS, multiple copies of the Partial Termination were duly filed for recordation with the Surface Transportation Board (the "STB") pursuant to 49 U.S.C. Section 11301, on October 13, 2004 and assigned Recordation Numbers 22738-C, 22739-C, 23044-C and 23580-B; and

WHEREAS, Mitsui USA and MRC desire to terminate and release the Lease Agreement and the Schedules and to terminate and release the Memorandum and to record such termination and release with the STB.

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt of which is acknowledged, Mitsui USA and MRC, intending to be legally bound, agree as follows:

1. Mitsui USA and MRC hereby terminate the Lease Agreement and the Schedules, in each case effective as of the termination date identified on Schedule B attached hereto (each, a "Termination Date") with respect to each unit of Equipment, and Mitsui USA and MRC hereby agree that no rights, duties or liabilities under the Lease Agreement and Schedules shall survive such termination and cancellation of the Lease Agreement and Schedules on


- the applicable Termination Date, except with respect to acts, events, or omissions under the Lease Agreement and Schedules occurring on or prior to the applicable Termination Date.
2. Mitsui USA and MRC hereby terminate the Memorandum, effective as of the applicable Termination Date with respect to each unit of Equipment. The parties agree to record this Termination with the STB so as to release any lien against the Equipment created by or arising out of the Memorandum.
 3. This Termination shall be governed by and construed in accordance with the laws of the State of Illinois applicable to agreements made and to be performed entirely within such state.
 4. This Termination may be executed in any number of counterparts, each executed counterpart constituting an original but all together constituting only one and the same Termination. No modifications or waivers of this Termination will be binding on either party unless made in a writing that specifically references this Termination and that is signed by persons authorized to sign agreements on behalf of both parties. If any provision of this Termination is held to be invalid, void or unenforceable, the remaining provisions shall nevertheless continue in full force. This Termination constitutes the entire agreement of the parties and supersedes all prior agreements, promises, representations, understandings and negotiations between the parties, whether written or oral, with respect to the subject matter hereof.


