This MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT ("Assignment") is made and entered effective as of April 1, 2007, by and between The Andersons, Inc. ("Assignor") and Wells Fargo Equipment Finance, Inc. ("Assignee").

WHEREAS, The Anderson, Inc., as Lessor, and General Mills Operations Inc. as Lessee, have heretofore entered into that certain Full Service Lease Agreement Lease Number #199602-GEN dated August 1, 1996, and Rider Deal #R010163 made on December 12, 2006 (collectively, the "Lease") pertaining to the rail cars described therein ("Equipment").
