MEMORANDUM OF RAILCAR LEASE

THIS MEMORANDUM OF RAILCAR LEASE dated as of this 12 day of February, 2007, is made by CIT FINANCIAL (ALBERTA) ULC., an Alberta company, with an address at 700 - 4th Avenue SW., Suite 1070, Calgary, AB T2P 3J4, CANADA (the "Lessor"), and ELLISON MILLING COMPANY, a Canadian corporation, with an address at 1301 - 2nd Avenue South, Lethbridge, AB T1J 3Z1, CANADA (the "Lessee" and, together with the Lessor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee entered into that certain Master Railcar Lease (the "Lease") dated as of February 12, 2007 covering certain equipment described therein and with respect to which a Memorandum of Railcar Lease was filed with the Surface Transportation Board ("STB") on APRIL 16, 2007 and given Recordation Number 26922.
