



RELEASE AND TERMINATION OF
TRUST INDENTURE AND SECURITY AGREEMENT

SURFACE TRANSPORTATION BOARD

This Release and Termination of Trust Indenture and Security Agreement, dated as of June 19, 2007 (the "Release"), is made by The Bank of New York Trust Company, N.A., successor-in-interest to J.P. Morgan Chase Bank, National Association, successor-by-merger to Bank One Trust Company, N.A., successor-by-merger to The First National Bank of Chicago (the "Indenture Trustee").

WHEREAS, the Indenture Trustee and Wilmington Trust Company, the Grantor, entered a Memorandum of Trust Indenture and Security Agreement dated as of November 6, 1997 (the "Indenture"), which was recorded at the Surface Transportation Board (the "STB") on November 6, 1997 at 2:30 pm under Recordation No. 20981.¹

WHEREAS, the Indenture Trustee and the Grantor entered a Memorandum of Supplement No. 1 to Trust Indenture and Security Agreement dated as of November 6, 1997 ("Supplement No. 1"), which was recorded at the STB on November 10, 1997 at 1:15 pm under Recordation No. 20981-A and 18847-K.

WHEREAS, the Indenture Trustee and the Grantor entered a A Memorandum of Amended and Restated Trust Indenture and Security Agreement dated as of June 30, 1998 (the "Amended Indenture"), which was recorded at the STB on June 30, 1998 at 11:20 am under Recordation No. 20981-B.²

WHEREAS, as of the date hereof, all obligations and sums due under the Indenture, the Supplement No. 1, and the Amended Indenture have been discharged and satisfied in full.

WHEREAS, the Indenture Trustee desires to execute this Release to evidence for the public record the satisfaction and release of all of its rights and interests in and under the Indenture, the Supplement No. 1, and the Amended Indenture, and in all of the equipment thereunder.
