Dear Mr. Williams:

**MEMORANDUM OF LEASE ASSIGNMENT  
(BN 1995-D)**

SURFACE TRANSPORTATION BOARD

Memorandum of Lease Assignment, made and entered into as of July 2, 2007, by and between Wilmington Trust Company, a Delaware banking corporation, not in its individual capacity, but solely as Owner Trustee (*"Owner Trustee"*) under the Amended and Restated Trust Agreement (BN 1995-D) dated as of July 2, 2007 between the Owner Trustee, in its individual capacity and the institution referred to therein as Owner Participant, and Wells Fargo Bank Northwest, National Association, a national banking association, as Indenture Trustee (*"Indenture Trustee"*).

**WITNESSETH:**

1. The Owner Trustee and BNSF Railway Company (*"Lessee"*) have entered into an Equipment Lease Agreement (BN 1995-D), dated as of June 15, 1995 (as amended, supplemented or modified, the *"Lease"*), covering certain railroad equipment bearing reporting marks as listed on Exhibit A attached hereto.

The Lease (or a memorandum thereof) was recorded with the Interstate Commerce Commission (as predecessor to the Surface Transportation Board) on June 29, 1995 at 10:05 A.M. under recordation number 19501 pursuant to Section 11303 of Title 49 of the United States Code (now known as Section 11301 of Title 49 of the United States Code).
3. The undersigned have entered into that certain Trust Indenture and Security Agreement (BN 1995-D), dated as of July 2, 2007, pursuant to which Wilmington Trust Company, not in its individual capacity, but solely as Owner Trustee, has assigned the aforesaid Lease and the rents and other proceeds therefrom (with certain exceptions) to Wells Fargo Bank Northwest, National Association, as Indenture Trustee.
4. A memorandum of said Trust Indenture and Security Agreement is being recorded with the Surface Transportation Board concurrently herewith pursuant to Section 11301 of Title 49 of the United States Code.


