

THIS TERMINATION OF LEASE OF PERSONAL PROPERTY ("Termination") is dated as of September 25, 2007 by M&I EQUIPMENT FINANCE COMPANY F/K/A M&I FIRST NATIONAL LEASING CORP., a Wisconsin corporation ("Lessor")

WHEREAS, Lessor entered into the Lease of Personal Property dated as of September 21, 2000 ("Lease") originally with Centennial Gas Liquids L.L.C. and later assumed by Palo Verde Investments, LLC, a Nevada limited liability corporation, with respect to the railcars as described in Schedule A attached hereto ("Units"); and
