

- A. Pursuant to the Rider No. 2 dated May 23, 1996 to the Loading Agreement dated February 20, 1996 between Greenbrier Leasing Company LLC, formerly known as Greenbrier Leasing Corporation, ("Lessor") and Railtex, Inc. ("Lessee"), Lessor leased two hundred seventeen (217) used 89-foot, TOFC flatcars marked and numbered MNA 901100 through MNA 901316, inclusive (the "Cars") to Lessee.

Lessor and Lessee executed a Memorandum of Loading Agreement for Rider No. 2 dated May 23, 1996 to the Loading Agreement dated February 20, 1996 (the "Memorandum") reflecting the lease of the Cars from Lessor by Lessee.
