

MEMORANDUM OF MORTGAGE SUPPLEMENT NO. 2  
(UPRR 1999 B-4)

SURFACE TRANSPORTATION BOARD

Memorandum of Mortgage Supplement No. 2, made and entered into on June 16, 2008, by and between Union Pacific Railroad Company, a Delaware corporation, as Borrower ("*Borrower*") and Wells Fargo Bank Northwest, National Association, successor-in-interest to First Security Bank, National Association, a national banking association, as Indenture Trustee (the "*Indenture Trustee*").

## WITNESSETH:

1. Borrower and Indenture Trustee have entered into that certain Trust Indenture, Mortgage and Security Agreement (UPRR 1999 B-4), dated December 20, 1999 (the "*Mortgage*"), by which Borrower has granted a security interest to Indenture Trustee in order to secure Borrower's performance of certain obligations as described in the Mortgage.

2. A memorandum of said Mortgage and a memorandum of Mortgage Supplement No. 1 have been recorded with the Surface Transportation Board pursuant to Section 11301 of Title 49 of the United States Code on December 20, 1999 at 12:25 P.M. under recordation numbers 22634-B and 22634-C, respectively.



The undersigned have entered into that certain Mortgage Supplement No. 2 (UPRR 1999 B-4), dated June 16, 2008, whereby Borrower has granted, pursuant to the above-described Mortgage, a security interest therein to the Replacement Items of Equipment set forth on Exhibit B attached hereto, and the terms and provisions of the above-described Mortgage are extended to such Replacement Items of Equipment, and whereby the Indenture Trustee has terminated, released and discharged its security interest in the Items of Equipment set forth on Exhibit A hereto.




