

**PARTIAL RELEASE OF SECURITY INTEREST UNDER LESSOR SECURITY AGREEMENT**

THIS PARTIAL RELEASE OF SECURITY INTEREST dated June 17, 2008 is made and entered into by the undersigned, TREBON Verwaltungsgesellschaft mbH & Co. Vermietungs KG (the "*Lessor*").

For good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Lessor hereby terminates, releases and discharges its security interest in the railroad equipment set forth on Schedule I attached hereto which has been deemed to have suffered an Event of Loss.

Such security interest was granted pursuant to that certain Lessor Security Agreement (UPRR 1999 B-1) dated December 16, 1999 (the "*Lessor Security Agreement*"), among the Lessor, Wells Fargo Bank Northwest, National Association, successor-in-interest to First Security Bank, National Association (the "*Security Trustee*") and Union Pacific Railroad Company (the "*Lessee*"), as supplemented (i) a memorandum of which was duly recorded with the Surface Transportation Board on December 15, 1999 at 1:15 P.M. under Recordation Number 22607-D and (ii) a memorandum of which was deposited with the Registrar General of Canada on December 15, 1999 at 10:11 A.M. 
