ACKNOWLEDGMENT OF ASSIGNMENT OF SECURITY AGREEMENT

This Acknowledgment of Assignment of Security Agreement (this "Acknowledgment") is made and entered into as of July 23, 2008, by and among Lynn T. Cecil and Suzie Cecil, Trustees of the Cecil Family Revocable Trust, Rick Cecil, and Lynette Cecil, jointly and severally (collectively, "Assignors"), and John C. Nixon and Lisa L. Nixon, Trustees of the John and Lisa Nixon Family Trust, UAD February 11, 2003 ("Assignee"). The parties acknowledge and agree as follows:

1. The parties have entered into that certain Assignment of Judgment, of even date herewith, in which Assignors have sold, assigned, transferred and conveyed to Assignee, among other things, all right, title and interest in and to that certain Security Agreement, dated January 21, 2000, made by Yreka Western Railroad Company in favor of Assignors (the "Security Agreement").
2. The Security Agreement provides for a security interest in (i) a locomotive, Steam Locomotive No. 19, and (ii) a car, the "Santa Rosa" business coach.




