MEMORANDUM OF LOCOMOTIVE LEASE TERMINATION

SURFACE TRANSPORTATION BOARD

THIS MEMORANDUM OF LOCOMOTIVE LEASE TERMINATION (this "Memorandum") dated as of January 2, 2009, is by and between **Comerica Leasing Corporation**, a Michigan corporation, as lessor (the "Lessor") and **Grand Trunk Western Railroad Company** (successor by merger to Grand Trunk Western Railroad Incorporated), a Michigan corporation, as lessee (the "Lessee").

WITNESSETH:

WHEREAS, Meridian Trust Company (the "Trustee") (predecessor-in-interest to Lessor in respect of the Locomotives (as defined below) only) and Lessee entered into that certain Lease of Railroad Equipment (the "Original Lease"), dated as of June 1, 1990, covering (i) certain autoparts boxcars as described therein and (ii) the twenty (20) diesel-electric locomotives as described therein and in Schedule A hereto (the "Locomotives"), which was i) filed with the Interstate Commerce Commission (predecessor to the Surface Transportation Board) (the "STB") on June 27, 1990, with primary recordation number 16905 and ii) deposited at the Registrar General of Canada (the "RGC") on June 27, 1990;

WHEREAS, Trustee (predecessor-in-interest to Lessor in respect of the Locomotives only) and Lessee entered into that certain First Amendment to Lease of Railroad Equipment (the "First Amendment"), dated as of September 28, 1990 whereby, among other things, the Original Lease was bifurcated into separate instruments of lease covering (i), in the first case, such autoparts boxcars and (ii), in the second case, the Locomotives, (the Original Lease, as bifurcated by the First Amendment, in respect of the Locomotives only, being collectively, the "Locomotive Lease") which was i) filed with the STB on February 7, 1991 with secondary recordation number 16905-A and ii) deposited at the RGC on March 21, 1991;

WHEREAS, Lessor and Lessee entered into that certain Locomotive Amending Agreement (the "Locomotive Amending Agreement"), dated as of December 29, 2005 which, in the form of a Memorandum of Locomotive Amending Agreement dated as of December 29, 2005, was i) filed with the STB on January 10, 2006 with secondary recordation number 16905-F and ii) deposited at the RGC on January 4, 2006;

AND WHEREAS, Lessee has performed its obligations under the Locomotive Lease (as amended by the Locomotive Amending Agreement) and purchased the Locomotives from Lessor.

IN WITNESS WHEREOF, the parties wish to show for the public record that as of the day and year first above written:

- 1) The Locomotive Lease (as amended by the Locomotive Amending Agreement) was terminated by Lessor and Lessee (except for such indemnities which by their nature survive termination); and

2) Lessor sold the Locomotives to Lessee;

and accordingly have caused this Memorandum of Locomotive Lease Termination to be executed by their officers thereunto duly authorized.
