SECOND AMENDED AND RESTATED MEMORANDUM OF LEASE AGREEMENT, LEASE
SUPPLEMENT NO. 1, LEASE SUPPLEMENT NO. 2, LEASE SUPPLEMENT NO. 3, LEASE
SUPPLEMENT NO. 4 AND LEASE SUPPLEMENT NO. 5
(Surface Transportation Board)

THIS SECOND AMENDED AND RESTATED MEMORANDUM OF LEASE, LEASE SUPPLEMENT NO. 1, LEASE SUPPLEMENT NO. 2, LEASE SUPPLEMENT NO. 3, LEASE SUPPLEMENT NO. 4 AND LEASE SUPPLEMENT NO. 5 dated as of June 24, 2009, is between CIT RAIL TRUST 2006-1, a Delaware statutory trust (the "Lessor"), and THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation (the "Lessee").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. The Lessee has leased the railcars identified on Schedules 1, 2, 3, 4 and 5 attached hereto (the "Equipment") from Lessor under Lease Supplement No. 1, Lease Supplement No. 2, Lease Supplement No. 3, Lease Supplement No. 4 and Lease Supplement No. 5 to that certain Equipment Lease Agreement (CIT Rail Trust 2006-1), dated as of June 30, 2006 (hereinafter together as amended, modified, supplemented and or replaced from time to time as the "Lease").

B. On June 30, 2006, a Memorandum of Lease Agreement, Lease Supplement No. 1, Lease Supplement No. 2, Lease Supplement No. 3, Lease Supplement No. 4 and Lease Supplement No. 5 was entered into and filed with the Surface Transportation Board at 2:41 p.m. under recordation number 26436.

C. On October 31, 2008, an Omnibus Amendment (CIT Rail Trust 2006-1) was entered into by the parties thereto to correct the reporting marks and road numbers of certain units of Equipment.

D. On October 31, 2008, an Amended and Restated Memorandum of Lease Agreement, Lease Supplement No. 1, Lease Supplement No. 2, Lease Supplement No. 3, Lease Supplement No. 4 and Lease Supplement No. 5 was entered into and filed with the Surface Transportation Board at 12:15 p.m. under recordation number 26436-B.

E. On June 24, 2009, a Second Omnibus Amendment (CIT Rail Trust 2006-1) was entered into by the parties thereto to correct the reporting marks and road numbers of certain units of Equipment. The corrected reporting marks and road numbers of the Equipment are set forth on Schedules 1, 2, 3, 4 and 5 attached hereto, which Schedules 1, 2, 3, 4 and 5 represent the corrected and complete lists of railcars.

F. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first above written.

G. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.
