I am enclosing for recording pursuant to Section 11301 of Title 49 of the United States Code, two executed copies of the Memorandum of Lease and Indenture Supplement No 2 (UPRR 1997-A-1), dated as of August 27, 2009, between Union Pacific Railroad Company, as lessee (the "*Lessee*"), Wilmington Trust Company (successor to Chase Bank USA, National Association, formerly known as Chase Manhattan Bank Delaware), as owner trustee of the UP 1997 Trust for AmSouth, as lessor (the "*Lessor*"), and Citibank, N.A., as indenture trustee (the "*Indenture Trustee*"), a secondary document as defined in the Surface Transportation Board's Rules for the Recordation of Documents



MEMORANDUM OF LEASE AND INDENTURE SUPPLEMENT NO. 2
(UPRR 1997-A-1)

SURFACE TRANSPORTATION BOARD

Memorandum of Lease and Indenture Supplement No. 2 effective as of August 27, 2009, by and between Wilmington Trust Company, (successor to Chase Bank USA, National Association, formerly known as Chase Manhattan Bank Delaware), a Delaware banking corporation, not in its individual capacity, but solely as Owner Trustee of the UP 1997 Trust for AmSouth, as Lessor ("*Lessor*"), Union Pacific Railroad Company, a Delaware corporation, as Lessee ("*Lessee*") and Citibank, N.A., a national banking association, as Indenture Trustee (the "*Indenture Trustee*")

WITNESSETH:

1 Lessor and Lessee have entered into that certain Lease Agreement, dated as of August 1, 1997 (as amended, supplemented or modified, the "*Lease*"), whereby Lessor has agreed to lease to Lessee and Lessee has agreed to lease from Lessor certain railroad equipment effective as of the date first set forth therein and subject to the term defined in said Lease. Lessor and Indenture Trustee have entered into that certain Indenture and Security Agreement (UPRR 1997-A-1), dated as of August 27, 2009 (the "*Indenture*"), by which Lessor has granted a security interest in the railroad equipment leased to Lessee under the Lease to Indenture Trustee (with certain exclusions and exceptions specified in the Indenture) in order to secure Lessor's performance of its obligations as described in the Indenture

2. A memorandum of the Lease was recorded with the Surface Transportation Board on August 19, 1997 at 10:49 A.M. under recordation number 20825 pursuant to Section 11301 of Title 49 of the United States Code. A memorandum of the Indenture is being recorded with the Surface Transportation Board concurrently herewith pursuant to Section 11301 of Title 49 of the United States Code

3 The undersigned have entered into that certain Lease and Indenture Supplement No 2 (UPRR 1997-A-1) (the "*Lease and Indenture Supplement*"), dated August 27, 2009, whereby the terms and provisions of the above-described Lease are made applicable to certain railroad equipment bearing reporting marks as listed on Exhibit A attached hereto and whereby Lessor has granted, pursuant to the above-described Indenture, a security interest therein to the railroad equipment leased to Lessee under the Lease (with certain exclusions and exceptions specified in the Indenture).

4 This Memorandum of said Lease and Indenture Supplement may be executed in any number of counterparts, all of which together shall constitute a single instrument






