**NOTICE OF SATISFACTION AND RELEASE OF SURFACE TRANSPORTATION BOARD
CHattel MORTGAGE AND SECURITY AGREEMENT**

The undersigned, UNUM LIFE INSURANCE COMPANY OF AMERICA ("Unum"), publishes this notice that the terms and conditions of the Chattel Mortgage and Security Agreement dated as of July 20, 1989 (the "Chattel Mortgage") between Teco Investments, Inc. as the Owner and Unum Life Insurance Company of America as the Secured Party have been satisfied in full. In addition, Teco Investments, Inc as Assignor and Unum as Assignee entered into that certain Lease Assignment dated as of July 20, 1989 (the "Lease Assignment") with respect to that certain Master Lease Agreement dated as of July 20, 1989 by and between Teco Investments, Inc., Lessor and The Detroit Edison Company, Lessee Accordingly, Unum releases any mortgage, security interests, assignments and all other rights it may have under the Chattel Mortgage and the Lease Assignment.


