A Pursuant to the Lease Agreement dated September 1, 2004, and Schedule No. 2 thereto dated as of May 16, 2007, between Greenbrier Leasing Company LLC, formerly known as Greenbrier Leasing Corporation ("Lessor") and Revett Silver Company ("Lessee"), Lessor leased to Lessee six (6) open-top solid-bottom mill gondola railcars, bearing marks and numbers AOK 32669 through AOK 32674, inclusive (the "Cars").
