This Release of Lien of Railroad Equipment Lease (the "Release") releases the lien created by that certain Locomotive Equipment Lease dated as of November 27, 2001 (the "Lease"), bearing Recordation No. 23924, between The David J. Joseph Company f/k/a Joseph Transportation Services, Inc., as Lessor ("Lessor") and Southwestern Railroad Company, Inc., as Lessee ("Lessee"), with respect to one (1) locomotive bearing reporting mark DJPX 2003, (the "Locomotive").


1. Lessee and Lessor have agreed to terminate the Lease between the parties effective as of October 7, 2002.


