

PARTIAL TERMINATION AND RELEASE OF SECURITY INTEREST

For value received, Citicorp Railmark, Inc. ("Secured Party"), only with respect to the railroad equipment described in Schedule I attached hereto (the "Released Railcar"), terminates and releases any and all rights and interests of Secured Party with respect to the Released Railcar, including, without limitation, any security interests in the Released Railcar created pursuant to the Purchase and Sale Agreement dated as of June 23, 2008 between Secured Party, as seller, and Equa-Chlor, LLC, as buyer (the "Purchase Agreement").

A memorandum of Secured Party's rights and interests with respect to the Released Railcar and other railroad equipment under the Purchase Agreement was recorded with the Surface Transportation Board on February 23, 2009, under Recordation Number 27819. To the extent (but only to the extent) related to the Released Railcar, Secured Party releases and terminates its rights and interests covered by such memorandum.


This Partial Termination and Release of Security Interest shall have no effect on the Secured Party's lien and security interest in any railroad equipment other than the Released Railcar.
