TERMINATION OF LEASE AND RELEASE**SURFACE TRANSPORTATION BOARD**

This TERMINATION OF LEASE AND RELEASE dated June 16, 2010 (the "Termination and Release") is made by Wilmington Trust Company, not in its individual capacity, but solely as Trustee under the Trust Agreement (Amtrak Trust 2000-B) dated as of June 13, 2000 (in such capacity, the "Lessor").

WITNESSETH

WHEREAS, the Lessor and National Railroad Passenger Corporation, a corporation organized under the Rail Passenger Service Act and the laws of the District of Columbia ("Amtrak"), are parties to that certain Lease of Railroad Equipment (Amtrak Trust 2000-B) dated as of June 13, 2000 (the "Lease") and that certain Lease Supplement No 1 (Amtrak Trust 2000-B) dated June 13, 2000 ("Supplement No. 1" and collectively with the Lease, the "Lease Agreement"), Supplement No 1 together with the Lease were filed and recorded on June 13, 2000 at 12:13 p.m. with the Surface Transportation Board ("STB") and were assigned recordation No. 22950;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lessor agrees as follows:

Section 1. Definitions. All terms used and not otherwise defined herein shall have the respective meanings provided in the Lease Agreement.

Section 2. Termination of Lease and Release of the Equipment. All right, title and interest of the Lessor in and to the Equipment described on Annex A hereto is hereby terminated and released. Amtrak and Lessor hereby terminate and cancel the Lease Agreement.

Section 3. Further Assurances. The Lessor hereby agrees to execute and deliver to Amtrak and its successors and assigns, at Amtrak's or its successors and assigns' cost and expense, as the case may be, such additional instruments, notices, releases or certificates as Amtrak or its successors and assigns, as the case may be, may reasonably request to effectuate the foregoing provisions of this Termination and Release.


