**NOTICE OF TERMINATION OF LEASE**

The Lease Agreement and Supplement No. 1 were duly filed and recorded with the Interstate Commerce Commission (predecessor to the Surface Transportation Board (the "Board")) pursuant to the provisions of 49 U.S.C. Section 11303 on December 27, 1990 at 9:15 a.m. under Recordation Number 17146 and 17146-B, respectively. This document constitutes a release of all interests, claims, liens, or encumbrances over the railroad equipment covered by the Lease Agreement at any time.

This Notice of Termination of Lease is executed without prejudice to the rights or obligations of the parties which expressly survive under the Lease Agreement or the termination agreement between the parties.
