The undersigned, **BANK OF AMERICA LEASING AND CAPITAL, LLC** ("BALCAP"), successor in interest to General Electric Railcar Service Corporation, and LaSalle Bank National Leasing Corporation, Lessor, publishes this notice that the Rider 71 to Car Leasing Agreement, dated as of December 12, 2005, incorporating by reference the terms and conditions of Car Leasing Agreement No. 8812-13, (the "Lease"), between Lessor and Union Pacific Railroad, Lessee, is hereby fully terminated.
